<b>CONDITIONS:</b>	1) Inflatable clause as per policy wording  2) The laws of England and Wales govern this contract and any claim recoverable hereunder.  3) <u>Trampoline Warranty: For Equipment <b>without</b> protective netting.</u>  It is hereby warranted that: -  1. Only one person may use the trampoline at any one time. 2. Children Under 3 Years Of age are not allowed on the trampoline 3. All Surfaces around the trampoline should be covered in adequate soft padding to avoid fall injuries. Further Safety pads should cover springs, hooks and frames. 4. Parental and/or Adult supervision must be provided at all times. 5. Make sure there is a 2m (6ft) safety zone on at least 2 sides of the equipment.	

**4) Bungee Run Warranty:**

It is hereby warranted that when a Bungee Run is hired out, it must be accompanied by the insured or an appointed representative of the insured who must have adequate training and competence in handling the equipment.

**5) Inflatable Slide Warranty:**

It is hereby warranted that whenever a slide with a platform height exceeding 3.0 m or 10ft is hired out, it must be accompanied by the insured or an appointed representative of the insured who must have adequate training and competence in handling the Slide

**6) Licence Premises Extension:**

It is hereby noted and agreed that the hire to and /or use of such equipment to Licensed venues will be:

- a) Not More than eight consecutive days in any hire contract  
And  
Such hires are limited up to four times in any one period of insurance to the same client and/or location and/or venue, for any item as listed on the Schedule attaching to the policy
- b) Excluding Nightclubs and premises holding late night license extension where there is a dance floor and dancing is allowed or permitted.

**7) Sumo Suit Warranty, It is hereby warranted that:**

- a) Male and Female participants must not compete against each other.
- b) Children under the age of 16 may only compete against children of the similar age and size.
- c) The competition 'ring' if set up on concrete and / or car park or similar surface must have:
  - i) Safety crash mats, made from high density flame retardant foam and flame retardant PVC. Mats must be a minimum of 2 inches in thickness.
  - ii) Provide air cushions or air beds and / or additional mats to supplement the actual 'ring' to prevent injury to combatants, when pushed out of the 'ring'.
- d) The 'ring' must have a clearance of a minimum of 2 metres from the edge to any walls, obstructions and / or obstacles.
- e) All protective clothing and / or apparatus must be secured properly in accordance with the manufacturers specifications.

**8)** The policy carries an excess of £500 (unless stated differently) each and every claim in respect of Public and Products Liability. The insured will be required to pay the policy excess immediately upon the notification of each and every claim received from a third party. If the claim is a Nil claim, or is closed within 12 months of notification, the insured will be refunded by the Insurers.

**9)** It is hereby warranted that the policy is incepted based on the list of equipment below and is adjustable throughout the contract of insurance. Equipment may be added by Abbots Parties throughout the insurance contract.

The insurers need not be informed of changes to this list of equipment as long as the new units are Class 1 & Class 2 category items. (See List Below)
